MONIKA BHATTACHARYA** under the name and style "**PANCHAJANYA TRUST**" by virtue of executed Trust Deed on on the 19th Day of May 1998. (hereinafter referred to as Original Trust Deed.)

WHEREAS by virtue of the nominated objects clause of the referred, Original Registered Trust Deed dated 19/05/1998, executed and duly registered under Indian Registration Act, bearing number 9437/98 to provide services for charitable purpose meant for public viz. to spread education at all level by way of running, development, improvement and extension of School, College, Medical College, running, development, improvement and extension of Hospitals, Clinics, Dispensaries, Day care and Diagnostic Centre (for Poly Clinic, Doctor's Chamber, minor operations), development and invention and a research Centre and/or institution for promotion of research and education for medical science including surgery.

And whereas the detailed objectives shall remain continue as stated in original Deed of Charitable Trust dated 19th May of 1998 and amended, detailed in First Supplementary Deed of Trust dated 3rd May of 2018 both are Registered under Indian Registration Act, and as amended from time to time under Indian Trust Act 1872 as amended and Indian Income Tax Act, 1961 Read with Rule framed as amended.

WHEREAS First Supplementary Deed of Trust was effective from 1st April, 2018 for all practical purposes.

WHEREAS DR. SUBRATA BHATTACHARYA, the Managing Trustee of "PANCHAJANYA TRUST" died on 23rd May, 2021 per Certificate of Death issued by Kolkata Municipal Corporation bearing Registration Number HG013/2021/ 002937.

WHEREAS the continuing and sole Trustee **SMT. MONIKA BHATTACHARYA**, party to the **FIRST PART** due to her old age decided to admit her son **SHRI SUMAN BHATTACHARYA** party to the **SECOND PART**, **SMT. ARUNDHUTI BHATTACHARYA**, party the **THIRD PART** and **SMT.SHRAVANI BHATTACHARYA** party to the **FOURTH PART** as Trustees along with her.

WHEREAS it has been further decided by her and other aforesaid specified persons that **SHRI SUMAN BHATTACHARYA shall be the Working and active Managing Trustee** of the present "**PANCHAJANYA TRUST**".

WHEREAS the other specified intended Trustees shall be the working and active Trustees.

NOW THIS INDENTURE WITNESSETH AS FOLLOWS:

1. That in pursuance of the said desire and for the promotion of such objects as hereinafter mentioned **TO HAVE AND TO HOLD TO CONTINUE THE TRUST** for its objects as described below, under para numbers 3(a) to (n).

2. THE NAME AND STYLE OF THE TRUST:

The name and style of the Trust Shall continue to be "**PANCHAJANYA TRUST**" a non-Commercial non-profitable and non-political Trust and the Registered Office of the trust shall be continued at P-176, Kalindi, Post Office Lake Town, Kolkata 700089 the address shall be correspondence only but not trust property. However, there may have additional which may be extended and/or relocated from time to time to such other place or place as the trustees may deem fit and proper per resolution to be passed by the majority of Trustees either at the meeting of the Governing Body Trust or by circulation thereof.

3. THE OBJECTS OF THE TRUST ARE:

- a) To spread education and for achieving the said object to establish, maintain, run, develop and improve, extend, grant donation in cash, and aid and assist in the establishment, maintenance, running development, improvement and extension of schools, college, workshops, Industrial and technical schools, engineering college, medical college, Online Exam Centre, Diagnostic Centre, day care hospital institution for the promotion of agricultural and educational institutions of any other nature.
- b) To establish, maintain or acquire library or libraries for the benefit of the student community.
- c) To institute and award scholarships in India for the study, research and apprenticeship for all or any of the aforesaid educational purposes.
- d) To have establishment, maintain, run, develop, improve, extend, grant donations, aid and assist in the establishment, maintenance, running development, improvement and extensions of hospitals, Diagnostic Centre, day care clinics, x-ray Plants, dispensaries, maternity house, recreation centres and all similar institutions as well affording treatments to alleviate human sufferings.

- f) To promote and inoculate the dignity of labour, the appreciation of intellectual gifts and talents or all kinds.
- g) To encourage sportsman and adventures spirit in the pupils and those connected with the institutions and coming in contact with them and to participate in game of skill and powers.

- h) To develop disciplinary conduct and to a habit to observe the rule of Law and self-restraint.
- i) To bring out, encourage and development inventive and research faculties of the pupils and teachers and to afford opportunity for research work in art, science, commerce and industrial undertaking.
- j) To carry on community development programs for the upliftment of the economically weaker sections of the society and also construct and develop community centres or halls for carrying on such activities.
- k) To open, found, establish, promote, set-up, run, maintain, assist, finance, support and/or aid-or help in the setting up and/or maintaining and/or running hospitals, charitable dispensaries, maternity homes, child welfare centres, convalescent homes, sanatorium, hostels and other similar institutions or centres for rendering or providing medical relief and/or aid to the suffering humanities or for research centres and institutions for promotion of research and education for medical science including surgery.

4. BOARD OF TRUSTEE:

The Board of Trustee will ordinarily consist of not less than 3 (three) and not more than 9 (nine) members.

- a) The named trustee first written above shall hold office for life. The Trustee however may co-opt. to the Board of Trustee, if necessary, to make the total number to 9 (nine).
- b) The Trustee co-opted shall hold office for two years and liable for retirement. The trustee whose term of office expires after the period of two years, are eligible to be co-opted as Trustee again by the existing Trustee. The trustee may if he/she so desires resign his/her Trusteeship even before the expiry of the term or his/her Trusteeship.
- c) The Trustees shall appoint one among them as managing Trustee of the Board of Trustee.
- d) **Shri Suman Bhattacharya** shall be the **Managing Trustee** for life. The aforesaid Managing Trustee shall act as Chairman and preside over all the meetings of the Board of Trustees.
- e) The Managing Trustee **SRI SUMAN BHATTACHARYA** and the Trustee **SMT MONIKA BHATTACHARYA** are jointly to execute and sign all necessary and required documents for all purposes and shall be the authorised joint signatory in respect of the bank transactions, statutory and all other necessary documents, not prejudicial to the interest of the Trust.
- f) **SMT. ARUNDHUTI BHATTACHARYA** the named Trustee of the **THIRD PART** shall also be **one of the signatory but of passive use so long the Managing Trustee Suman Bhattacharya and Trustee Monika Bhattacharya are present.**
In absence of any one of them and/or in the event of being incapacitated her status of passive signatory shall be active as one of the joint signatories and her signature shall be valid for all purposes.

- g) The permanent Trustees are authorized to co-opt. one or two additional Trustees and determine the terms of their appointment but failure to nominate such Trustee or Trustees shall not invalidate the Trust or any action taken by the Trustee or Trustees herein.

5. MEETING OF THE BOARD OF TRUSTEES:

In the absence of the Managing Trustee at any meeting, The Trustees present may elect one among themselves as Chairman of the Meeting.

6. POWERS AND DUTIES OF THE BOARD OF TRUSTEE:

- a) The Trustees may received donations of money and/or properties and when so received shall at the absolute disposal of the Trustees.

- b) To charge tuition fees and otherwise recoup themselves for the outlay and expenses incurred in the up keep and maintenance of institutions establishment or to be established under this Deed.

- c) The Trustees shall invest the properties and money of the Trust in such manner as prescribed under sec.11 of the income Tax Act, 1961 and other statutory Laws as amended and in force and also per new Laws that will he introduced.

- d) The Trustees are empowered to invest the funds of the Trust in any movable property or nay other investment as may be determined by the Trustee from time to time and likewise the Trustee are authorized to realise the investment from time to time.

- e) The Trustees are empowered to acquire both movable and immoveable properties for the Trust and likewise have the power to sell, mortgage or otherwise deal with the property of the Trust both moveable and immoveable.

- f) Bank account or accounts may be opened for the Trust which may be operated by the Managing Trustee or by any person authorized by the Trustees from time to time.
- g) The Board may by resolution extend the activities or undertake any activities in furtherance of the main objects of the Trust.
- h) The Board of Trustees shall meet as often as necessary and their proceedings shall be recorded regularly in the Minutes Book to be retained for the purpose.
- i) In any resolution to be passed, regarding Administration of the Trust, the opinion of the majority shall prevail. The Chairman of the meeting shall have casting vote to decide the issue if there is difference of opinion amongst Trustees.
- j) The Trustees may manage or supervise the management of any Lands, hereditaments and premises for the time being comprised in the Trust Estate or any part thereof with power to erect, pull down, re-build, alter and repair houses and fences and otherwise to improve and develop and to cultivate or cause to be cultivated all or any of the said lands hereditaments and premises and to insure house and buildings against loss or damage by fire and/or other risks or to let out, lease, make allowance to and arrangement with tenants, agriculturists and generally to deal with the said lands, hereditaments and premises as they may deem fit and proper in their absolute discretion.
- k) The Board of Trustee may taken house and other building or building on rental and/or lease basis and to pay the rent as my be determined from time to time.

7(A). CUSTODY OF DIOCUMENTS:

The Managing Trustee or his nominee(s) shall have the custody or all documents, Title Deeds relating to the Trust properties and investment, the books of account

and other records relating to the Trust and shall be responsible for the preservation of the same.

7(B). REGISTRATION:

This Amended Deed Trust Second Supplementary shall be registered under the Registration Act, 1908, as amended from time to time and shall also be registered under section 12AA of the Income Tax Act, 1961, as amended from time to time.

SCHEDULE OF THE TRUST

The trust has no property either moveable or immoveable except trust fund amount of ₹10,000/-.

8. ADVISORY BOARD:

The Trustee may maintain a set of advisers for the purpose of utilizing their services in furtherance of the objects of the Trust. But the failure to nominate such advisory Board shall not invalidate the Trust or any action taken by the Trustee or Trustees herein.

9. WINDING UP:

The Trustees may under unanimous resolution passed by all of them, for the time being, and also with the respective written consent of winding up, the affairs of the Trust in accordance with law and on such winding up the Trustee shall hand over the properties of the Trust to any other Trusts or Institutions having similar objects

10. CHARITABLE TRUST:

It is expressly declared that no part of the Trust property or its income shall be applied out of India or for any purpose which is not a public charitable purpose in law and all provision hereof shall be construed accordingly.
